Students are required to earn the minimum test scores by the deadline for the semester they plan to begin taking courses.

- Students must complete a DSC application to be eligible to take a placement test at DSC.
- Students must earn the the minimum scores for both reading AND writing.

Students using SAT, PSAT, ACT, PSAT, or CLT scores will need to provide official scores at time of registration.

Effective Fall 2024, MGF2106 has been replaced by MGF2130 -Mathematical Thinking, which is intended for a non-STEM major.

USING HIGH SCHOOL COURSEWORK AS PLACEMENT

Students with an unweighted high school GPA of 3.0 and a grade of "B" or higher in any of the courses listed to the right shall have demonstrated readiness for college-level work.

- Allows entry to MAT1033/MGF2107/MGF2130 and ENC1101 only.
 Students requesting a higher-level math will need to earn the minimum scores listed in the placement test chart above.
- Students using math coursework as placement must also meet the minimum SLS1122 reading/writing placement to begin the Dual Enrollment program.
- DSC accepts courses and grades on the public high school transcript as an official record.

Accelerated High School Courses

Students may use AP/IB/AICE courses to place into college credit courses. Students must complete the course, earn the minimum exam score, and provide confirmation of exam score at time of registration. Review the Credit-By-Exam Equivalency Chart for details.

CAREER & TECHNICAL EDUCATION (CTE) PROGRAM PLACEMENT

Students are required to take the CASAS test for Career & Technical Training to be eligible for enrollment in a Vocational Certificate program, but are not required to earn the minimum test scores to begin taking courses. Exit scores may be required at the end of the program for certificate completion.

 Students with qualifying ENC1101 and MAT1033 scores on the PERT, SAT, ACT, or CLT scores are exempt from taking the CASAS.

TAKING A PLACEMENT TEST @ DSC

Apply for admission to DSC first: You will need a student ID number to be eligible to take the PERT or CASAS at DSC.

Where can you take PERT or CASAS? At any DSC Testing Center on any campus. Testing Center locations and hours can be found at www.DaytonaState.edu/testing-center. The PERT may also be offered at your middle or high school (attempts at the high school do not count toward attempts at DSC), check with your school counselor for details.

You will need a photo ID: All students (regardless of age) must have a current/valid photo identification (ID) to take any examination. This is including but not limited to a state ID, learner's permit, driver's license, school ID, or passport.

How long does the test take?

PERT: 1 hour per section (3 sections total). **CASAS:** 1 - 1.5 hour per section (2 sections total).

Is there a cost? There is no cost for the initial PERT attempt at DSC. Retakes at DSC are \$10 per section. There is no cost for the CASAS.

How many times can you take the test? There is no limit to the number of times a student may take the PERT, but they must wait 24 hours before retesting.

All exam sessions are monitored and recorded.

ADDITIONAL ITEMS TO NOTE FOR COLLEGE CREDIT PLACEMENT

- Students must meet the minimum SLS1122 reading/writing scores to begin taking college credit courses.
- Students with a cumulative, unweighted GPA of 2.5 that meet the minimum SLS reading & writing scores listed may enroll in SLS1122 only.
- Students who qualify for SLS1122 and meet the math placement, but not the reading/writing placement for ENC1101, may register for SLS1122 and math courses only.
- Students must meet the minimum math scores to take any math course or course that requires a math pre or corequisite.
- Students must also meet all other pre-requisites or co-requisites; however, students who are concurrently enrolled in a high school AP or AICE English course will be considered to have met the English pre-requisites or co-requisite for DSC courses, except ENC 1102.
