The verification form along with all supporting financial documents must be submitted to the Admissions Office before a SEVIS form I-20 will be issued. - n Individual sponsors (family, friends, etc.) - Submit a bank letter, or certificate of deposit, that includes the sponsor's name and the current balance in U.S. dollars or stating that there are funds in excess of the estimated cost of attendance (specify exact dollar amount). Submit with a signed Affidavit of Support (below) for each sponsor.
- n Government sponsor - Submit an award letter from the sponsoring government.
- n Daytona State College - If Daytona State will be providing you any funds such as an athletic scholarship, those documents must be attached.
